SUBJECT: Review Nomination and Recommend a Candidate for the CalTIP Board Vice Chair Position

### **BACKGROUND**

A solicitation for nominations to fill the CalTIP Board Vice Chair position as well as vacancies on the Oversight Committee, Finance and Administration Committee (FAC), and Member Services Committee (MSC) was distributed to the membership on August 30, 2019.

Per CalTIP's Bylaws, only members of the Oversight Committee are eligible to be nominated for the CalTIP Board Vice Chair position. However, any Board or Alternate Board member is eligible for nomination for any committee positions.

For the Committee's information, Mr. Geoff Straw, South County Area Transit, previously served as the CalTIP Board Vice Chair. In accordance with Article IV.B. of the Bylaws, upon the previous Board Chair's retirement in July 2019 (Mr. Art Ida, City of Culver City), Mr. Straw automatically succeeded to the Chair position; thereby, leaving the Vice Chair position vacant. Mr. Straw's Chair position is subject to ratification by the Board at its December 2019 meeting, and a new Vice Chair will be elected to fill the unexpired term, through April 30, 2020.

Staff received only one nomination for the Board Vice Chair position. The nomination was for Mr. Scott Ousley, Operations Manager, El Dorado County Transit Authority. Mr. Ousley has served on the CalTIP Board for approximately 17 years. He previously served on the Member Services Committee from 2011-2018, and is currently serving on the Oversight Committee.

The nominations for the Oversight Committee, FAC, and MSC positions will be discussed in the succeeding agenda items.

## **RECOMMENDATION**

Recommend the CaITIP Board, at its meeting in December 2019, elect Mr. Scott Ousley to serve as the Board Vice Chair for the remainder of the unexpired term, through April 30, 2020.

SUBJECT: Review Nominations and Recommend a Slate of Candidates for the CalTIP Oversight Committee Positions

### **BACKGROUND**

As discussed in the previous agenda item, a solicitation for nominations to fill a vacancy on the Oversight Committee was distributed to the membership on August 30, 2019. The vacant position was previously held by Mr. Steve Rosenberg, Gold Coast Transit District, who recently stepped down from the CalTIP Board. Mr. Rosenberg's term expires on April 30, 2020. In addition, there is one additional vacancy on the Oversight Committee due to the resignation of Mr. Art Ida, City of Culver City, from the CalTIP Board. Mr. Ida's term expires on April 30, 2020. Two nominations were received as follows:

- Kelly Halcon, Director of HR/Risk Management, Monterey-Salinas Transit District. Ms. Halcon has served on the CalTIP Board for 3 ½ years, and is currently serving on the Nominating Committee. Ms. Halcon has also been nominated to serve on the Member Services Committee which will be discussed under agenda item 5.D.
- Julia Tyack, Transportation Planner, City of Lodi. Ms. Tyack has served on the CalTIP Board for ten years. Ms. Tyack served on the Member Services Committee from 2009-2011 and is currently serving on the Finance and Administration Committee (FAC). Her term on the FAC expires on April 30, 2021.

The Nominating Committee should consider the nominations presented and direct staff to present a slate of one or both candidates to the Board at its meeting in December 2019. Per Governance Policy 2.10, the Nominating Committee may submit more than one candidate for each seat. Per the Bylaws, the Oversight Committee shall consist of "not less than seven nor more than nine members from the Board of Directors."

Recommend a slate of one or more candidates for election to the Oversight Committee by the Board at its meeting in December 2019 to fill vacancies on the Oversight Committee with terms expiring on April 30, 2020.

SUBJECT: Review Nominations and Recommend a Slate of Candidates for the CalTIP Member Services Committee Positions

### **BACKGROUND**

There are currently two vacancies on the CalTIP Member Services Committee (MSC), which were previously held by Ms. Katie Marsolan, City of Arcata; and Ms. Melissa Cummins, Siskiyou County. Both positions expire on April 30, 2020. A solicitation for nominations to fill both positions was distributed to the membership on August 30, 2019.

As of the writing of this report, three nominations were received, as follows:

- Lori DaMassa, Management Analyst II/Transit Coordinator, City of Vacaville.
   Ms. DaMassa assumed her position on the CalTIP Board in August 2018.
- Kelly Halcon, Director of HR/Risk Management, Monterey-Salinas Transit District. Ms. Halcon has served on the CalTIP Board for 3 ½ years and is currently serving on Nominating Committee.
- Matt Mauk, Executive Director, El Dorado County Transit Authority. Mr. Mauk has served on the CalTIP Board for two years, including his time as the City of Folsom's representative on the CalTIP Board (April 2017-May 2019).

Per the Bylaws, the Oversight Committee has the discretion to elect between seven and nine members to serve on the MSC. Including the two vacancies, the MSC is currently comprised of seven members, with four members serving May 1, 2018, to April 30, 2020, term; and three members serving term of May 1, 2019, to April 30, 2021.

The Nominating Committee will be asked to recommend a slate of candidates to fill two vacant positions on the MSC. The newly-elected MSC members' terms expire on April 30, 2020. The Nominating Committee could also recommend a candidate to serve from the date of election to April 30, 2021.

Pursuant to the CalTIP Bylaws, the Oversight Committee will conduct an election to fill the MSC positions at its meeting in October 2019. Per Governance Policy 2.10, the Nominating Committee may submit more than one candidate for each seat.

### **RECOMMENDATION**

Recommend a slate of candidates to be elected by the Oversight Committee, at its meeting in October 2019, to serve on the Member Services Committee.
