SUBJECT: Review Nomination and Recommend a Candidate to Serve on the Oversight Committee

BACKGROUND

On September 25th, the Nominating Committee held a meeting and recommended Julia Tyack, City of Lodi; and Kelly Halcon, Monterey-Salinas Transit District, to fill two (2) vacancies on the Oversight Committee. Subsequently, staff was notified of Scott Graham's retirement from Omnitrans effective November 6th, which created another vacancy on the Oversight Committee for the remainder of his term which expires April 30, 2020.

A solicitation for nominations for the additional vacancy on the Oversight Committee was distributed to the membership on October 21st. A nomination for Erin Rogers, Deputy General Manager of Omnitrans, has been received. The Omnitrans Board has appointed Ms. Rogers the Interim CEO/General Manager effective November 7th.

The Nominating Committee may make additional nominations from the floor.
